

#### JOB VACANCY: MINIBUS DRIVER & KIT COORDINATOR

Velocity Football in partnership with Ignite Sport & Oxford city FC are recruiting for a casual minibus driver to primarily transport students from Oxford Parkway station to Oxford City FC with a return journey in the afternoon. The role also includes the co-ordination of kit and equipment ahead of fixtures. The role will also include journeys to away fixtures, trips and other ad-hoc journeys as required.

Job Title: Casual Minibus Driver

**Main Purpose of Job**: To provide a reliable and courteous bus service to students on Monday/Tuesday/Wednesday/Friday

#### Main Tasks of Job:

- 1. To drive & carry out day-to-day maintenance of the minibus. This to include (but not exclusively):
  - Keeping the log sheet of journeys made
  - Refuelling the vehicle
  - Checking oil & fluid levels topping up as required
  - Checking of tyre pressures inflating as required
  - Both internal & external cleaning when required
  - Reporting any defects to management
  - Coordination and maintenance of playing kit, equipment and items required for fixtures
- 2. To safely drive the Minibus putting safety of yourself, passengers and other road users first.
- 3. To comply with all Health & Safety regulations including announcing to all passengers to put on their seatbelts before pulling away
- 4. To exercise care in the treatment of all personal, confidential and sensitive data to which the post holder has access and for which he/she has responsibility and to ensure that such information is not disclosed to any unauthorized person
- 5. To carry out any other tasks that may be required.
